MOTION re Chairperson of the Annual Congregational Meeting.

Operating Procedures of the Meeting

- **a. Constitution of the Meeting:** That the meeting had been properly called in accordance with The United Church of Canada Manual, Sections B.5.1, B.5.2, B.5.3, B.5.4.
- **b.Quorum:** That a quorum exists in accordance with The United Church of Canada Manual, Section B.5.5, which states, "for congregations of Pastoral Charges with 100 or more full members, at least 20 full members must be present".
- **c. Voting Process:** In accordance with The United Church of Canada Manual, Section B.5.6, which states: "Voting must be by show of hands unless the congregation or pastoral charge decides on another way of voting. Proxy voting or voting by mail-in ballots is not permitted".

d. Voting Entitlement:

- i. pursuant to section B.3.4.2. of the United Church of Canada Manual, the definition of an adherent is the responsibility of the governing body.
- ii. Trinity United Church, Smiths Falls defines an adherent as long standing, committed participants in the work and life of Trinity United Church who do not hold membership in another denomination.
